I also want to report that the payment process for longevity pay will be slightly modified this year. The "Longevity Pay" policy states in part that "Full-time employees who have been credited with 7 or more years of compensated full-time service with Forsyth County and who are on the payroll as of November 30, may receive an annual lump-sum longevity payment in December." Because November 30 is on a Saturday this year, we need to include employees who are on payroll as of Friday, November 29 since a large portion of our employee population do not work on the weekend. This is especially important for anyone wishing to retire during that period of time. Their "last day worked" would be November 29 which would unintentionally impact their longevity pay eligibility if we do not modify the payment process. This modification would only impact this year's longevity payment process. Please let me know if you have any questions or need additional information.
