Ladies and Gentlemen,

I am pleased to present the FY 2008-2009 Annual Budget for Forsyth County. The Preliminary Budget was presented on May 15th, a Public Hearing was held on May 27th, and a budget workshop was held on May 28th. The Budget Ordinance was adopted on May 29th, 2008.

This document reflects the adjustments to the General Fund Preliminary Budget identified in your review and as adopted in the formal Budget Ordinance. A summary of these changes are shown below. A more thorough description follows on the next page. The Adopted Property Tax Rate for FY 2008-2009 was decreased from the Preliminary Continuation Budget rate of \$.723 to the Adopted Rate of \$.696. The document also reflects the changes to the Property Tax Rates for the Fire and Rescue Districts.

Collectively, this budget represents hundreds of hours of work on the part of many people, particularly the Board, and deepest appreciation is extended to all of them.
