**EXPLANATION:**

This amendment transfers funds within the 2016 Pay-Go Capital Projects Ordinance from a Budget Reserve to an appropriation to Winston-Salem Industries for the Blind, Inc. for a manpower development program authorized by N.C.G.S. 160A-492 to assist Winston-Salem Industries for the Blind, Inc. with the purchase of AR coating equipment as identified during the FY2017-2018 Budget process as a one-time funding project. The remaining funds are set aside in a budget reserve to be used to offset the need to issue debt for the Library bonds passed in 2010 as well as possible elections equipment needs.

This 2016 Pay-Go Capital Projects Ordinance hereby authorizes the County Manager to execute the necessary documents to proceed with the Winston-Salem Industries for the Blind, Inc. Project, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
