## **EXPLANATION:**

Each year, the adopted budget includes funds to cover prior year encumbrances. For FY 2020-2021, \$1,800,000 was budgeted in Non-Departmental to cover prior year encumbrances. For FY 2019-2020, actual outstanding encumbrances as of June 30, 2020, totaled \$2,556,587,12.
