Photo ID for taxpayer (and spouse if filing jointly)	All childcare provider names, addresses and employer ID numbers (EIN) or Social Security Numbers
Last year's tax return	Evidence of deductible expenses
All documents reflecting earnings	Income and expenses for sole proprietorship (Schedule C)
W-2s, 1099s, Social Security statements (SSA-1099)	1095-A form if health care coverage is through Marketplace (ACA) insurance
Social Security ID or ITIN ID of each person on the tax return	Checking or savings account number for direct deposit of a refund
