A NAME – Review and correct as necessary. Please make corrections on the form and state the reason for the change (marriage, divorce, error). B IMPROVEMENTS TO REAL PROPERTY IF APPLICABLE – Enter the type and cost of any improvements to real estate (includes but not limited to: additions, new construction, decks, outbuildings, garages, remodeling, or demolition, etc.).

C MANUFACTURED HOMES, UNREGISTERED OR MULTI-YEAR/PERMANENTLY/IRP TAGGED MOTOR VEHICLES, BOATS, AND WATERCRAFT – Personal property must be listed annually.
